### What information do we collect and how do we use it?

Website Users' Data - We do not collect any unique information about you via our website - such as your name, email address, contact details, etc - except when you specifically provide it - ie. via newsletter subscription, creating user accounts, contact forms, email contact, etc.

Our Clients', Business Contacts' & Suppliers' Data - Our policy is to ask for, or collect and store only the business and personal data necessary for conducting business purposes and for relevant record keeping. Data may include name, position, phone number, email and other general contact details. #### Cookies
